I/we, the undersigned adopting party, understand and agree to the following terms and conditions of this contract in the acquisition of the above-described animal, hereinafter referred to as "cat":

1. To return the cat to the RESCUE if unable to keep the cat. To never abandon the cat or surrender, sell, or give the cat to a shelter, pet dealer, or a laboratory.
2. To notify the RESCUE if the cat is lost or stolen and to make all reasonable efforts to locate the cat.
3. To treat this cat as a family pet with affection and kindness, never subjecting this cat to abuse or cruelty.
4. The cat will be an INDOOR cat ONLY. Access to the outdoors is dangerous for the cat. The cat may be leash-walked.
5. To provide regular veterinary care, including annual vaccinations and parasite checks. If not already spayed or neutered, to have that done within 30 days of adoption, or prior to the animal being 6 months of age.
6. To not keep the cat confined to a single room or small area for long periods of time.
7. I will feed the cat at least once a day and will provide a continuous supply of fresh water (unless health conditions warrant otherwise).
8. To notify All 4 Animals Rescue of the cat's annual progress.
9. To allow All 4 Animals Rescue to periodically check on this cat.
10. To contact All 4 Animals Rescue, a veterinarian, or trainer when problems behavior occurs, so that the problem behavior may be eliminated or alleviated.

Non-compliance with any of the above terms and conditions may result in the immediate forfeiture of the cat and that All 4 Animals Rescue may reclaim this cat without payment of compensation to me/us.
